5. Appointment of faculty already done/ to be done in future and their pay and allowances must follow the latest NCTE/ UGC/ State govt. norms. It is advised to make payment to the staff of the college through A/C payee cheque drawn on a (preferably) Nationalized Bank. Action shall be taken if any irregularities are found in this regard.

In respect of maintenance of academic and financial discipline the college will strictly follow norms of NCTE (in strict observance of the latest notification)/State Government Orders issued from time to time and relevant conditions/rules of the Affiliating University in this regard especially with respect to the minimum number of teaching days in an academic session as stipulated by the Affiliating University/NCTE.
7. Expert(s), duly authorized by the University may make 'surprise visit' to the college for rapid, on-spot assessment of the quality of functioning. If any short-fall / discrepancy is identified by the Inspection Team, affiliation of the programme may be withdrawn.
8. The college authority shall abide by the Acts, Statutes, Regulations etc. of this University as are in force or as may be amended from time to time.
9. Admission of students will be as per norms stipulated by the University.
10. Staying in the college hostel, if any, is not mandatory for the students.
11. The Governing Body of the College is to be constituted as per provisions of the State Govt. / Affiliating University.
12. The following school subjects are approved as Pedagogy subjects for curriculum transaction at your college along with other foundation courses and optional courses, if any :

**Bengali, English, Sanskrit, History, Geography, Political Science, Life Science, Physical Science and Mathematics.**
